The image to be used on your order can be from any of these:

1. A traditional photographic print
2. A digital file from a digital camera, saved to a CD or DVD
3. A digital file from a scanned print, saved to a CD or DVD

For best results, we recommend that you follow a few basic guidelines. You should submit in-focus, close-up photos with good contrast and good exposure. Because of the fabric texture, an image with fewer subjects, and larger in the frame works best. When selecting an image, consider whether you want a vertical or horizontal finished piece for your home or office. For collages, keep the number of individual images to eight or fewer close-up images (fewer if images are full body).

Digital files should be at least 1250x960 pixels, or a file size of at least 1.25 megabytes (but bigger is better). The important subject matter in your image should be in a roughly 8x10 proportion for throws and tapestries, or a square format for totes and pillows. Coray Photo will determine the best cropping and placement of photos on your product. Minor file clean-up is included at no additional charge. If you need us to return your print or disk, you must indicate as such on the order form.
